

## Limited Warranty

## **STRUCTURE**

NW Green Panels guarantees the structural integrity of every greenhouse we build; this means we ensure that each greenhouse component will be assembled with pride and function correctly. NW Green Panels expects every greenhouse to withstand normal to severe conditions but does not guarantee against extreme weather damage and "Acts of God." NW Green Panels does not secure any of our structures to any foundation. If you are concerned that you are in a very high wind area, you will be responsible for securing the structure. NW Green Panels' glazed roof system is engineered/designed to maintain a leak-free environment; however, due to the nature of glazed roofing in a greenhouse environment, we do not guarantee that your structure will be water or airtight. If excessive infiltration occurs, we will instruct you, or your contractor, on how to minimize or eliminate the excessive infiltration. NW Green Panels offers help with the installation process but does not guarantee the installation done by a client or an outside contractor. NW Green Panels does not guarantee any greenhouse or greenhouse installation where the quality of the base is out of alignment with the description of the base expectations as outlined in the "Base Guide" and the "Sales and Delivery Agreement." Because of the cedar wood's knotty nature (that we use in our greenhouse components), we cannot guarantee the wood being free of warping or swelling due to moisture. If a component does warp past the point of functioning, we will provide a replacement of the part or component and instruct you, or your contractor, on installing the replacement part or component within the first five (5) years. NW Green Panels treats every greenhouse with an oil-based stain unless specified differently on the client's "Sales Order." The finish is not guaranteed and will need regular touch-ups, at the client's expense, to maintain the finish's quality. NW Green Panels guarantees the wood being free from rot for ten (10) years from the date of purchase, provided the greenhouse is elevated and away from any longterm standing water or saturated ground as outlined and described in the "Base Guide."

## **GLAZING**

All Materials used for glazing come with manufacturer guarantees. We guarantee the glazing materials are applied correctly. All glazing materials come with a ten (10) year guarantee against defects during normal exposure (e.g. becoming brittle or discoloring in the case of polycarbonate, and cracking or breaking a seal in the case of double pane glass). Should a glazing product become defective and fail, NW Green Panels will replace the defective part.

## **VENTING SYSTEM**

NW Green Panels uses automatic greenhouse vent openers to open and close our unique passive Ridgeline Ventilation System. All Auto-Rise lifters we use in our unique Ridgeline Ventilation System have a two-year (2-year) manufacturer warranty; if for any reason, your lifter should fail within those first two-years (2-years), contact NW Green Panels for replacement, and we will facilitate the exchange. (The Auto-Rise lifting mechanism is utilized as a component in conjunction with our uniquely engineered Ridgeline Ventilation System. The description of the Auto-Rise lifting mechanism's factory designed capabilities (listed in their manufacturers or owner's manual, and on their website) will not be the same once applied to our unique Ridgeline Ventilation System.)
